

% of Core Measure Perfect Care Performance




HBIPS— Hospital Based Psychiatric Services

⇒Patients must have an 'appropriate reason' for discharge on more than one antipsychotic medication

IMM—Global Immunization

⇒Influenza vaccination must be correctly assessed and documentation completed/vaccine given if "candidate" (Sept thru March).



HBIPS— Hospital Based Psychiatric Services

- ⇒Patient needs need to have medication reconciliation completed, including name, dose, route and INDICATION of each medication and supplement
- ⇒Patients must have an 'appropriate reason' for discharge on more than one antipsychotic medication
- ⇒Patients need to have a continuing care plan (Discharge Summary) written and transmitted to the next level of care provider within 5 days of discharge

VTE - Venous Thrombo-Embolism

⇒VTE patients (all) must receive VTE prophylaxis by Hospital Day 2 or need MD documentation of contraindications for both chemical and mechanical VTE prophylaxis

HBIPS— Hospital Based Psychiatric Services

- ⇒Patients must have an 'appropriate reason' for discharge on more than one antipsychotic medication
- ⇒Patients need to have a continuing care plan (Discharge Summary) written and transmitted to the next level of care provider within 5 days of discharge

SCIP—Surgical Care Improvement Project

AMI—Acute Myocardial Infarction

⇒Beta Blocker, Statin and ASA at discharge

- ⇒MD documentation for reasons extending antibiotics past 24 hours needed
- ⇒MD documentation for reasons extending antibiotics past 72 hours for cardiac cases
- ⇒Patients need to receive appropriate antibiotic

STK—Stroke

⇒Patients need VTE prophylaxis by Hospital Day 2 or MD document the contraindication for no mechanical or pharmalogical prophylaxis ⇒Patients need Antithrombotic Therapy administered by end of Hospital Day 2 or MD document the contraindication

STK-Stroke

⇒STK RN did not give medication per MD order

STK—Stroke

⇒Patients need to receive the mandated Stroke Discharge Instruction in WRITING
